These include (NAOT Staff, CSO, Media and other official from the Industry) on Auditing of Mining, Oil and Gas and it intends to apply part of proceeds of this fund to cover eligible payments under the contract for training staff as per attached scope of assignment as indicated in the TERMS of Reference (TOR).

4. You are requested to submit your written expression of interest, one original detailed Curriculum Vitae (CV) and Financial Proposal by 14th February 2019 at 10:00 hours local time. The Detailed CV and Financial Proposal shall each be enclosed in a separate envelope and marked "Detailed CV" and "Financial Proposal" respectively. The two envelopes shall then be enclosed in a single envelope and marked "Proposal for **CONDUCTING SPECIALIZED TRAINING TO 100 PARTICIPANTS (NAOT Staff, CSO, Media and Extractive Industry) ON AUDITING OF MINING, OIL AND GAS** " and submitted to the following address:

5. The Opening of CVs shall take place immediately after the deadline for submission, at National Audit Office, Conference room. Applying individual consultants are invited to attend the opening ceremony.
6. A consultant will be selected in accordance with the procedures set out in the Public Procurement Act No. 7 of 2011 and the Public Procurement Regulations, 2013 – Government Notice No. 446 (hereinafter called Procurement Regulations).
7. CV shall be evaluated on the basis of the criteria shown in the Terms of Reference. The Authority shall contact the first individual consultant in the ranking and if available, fees and contract terms shall be negotiated. If negotiation fails with the first consultant in the ranking the second consultant in the ranking shall be contacted until one is definitely retained for the assignment.
8. Prospective Individual Consultant is required to collect the Terms of Reference from The Secretary, Tender Board whose address is indicated on paragraph 4 above during Working days (Monday to Friday) between 08:00 a.m and 03:00 p.m)
